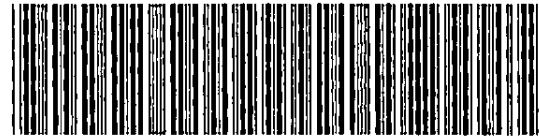

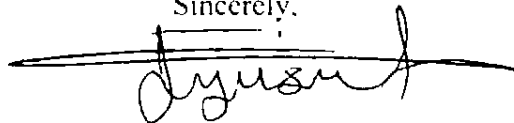

ARTICLE I. NAME

The name of this corporation is LATIF'S COAST TO COAST INC.

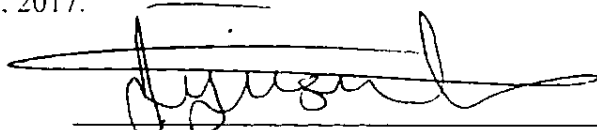

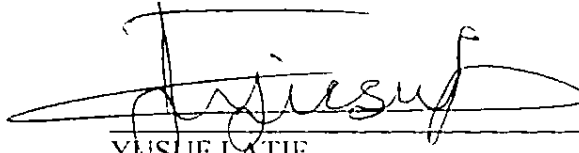
