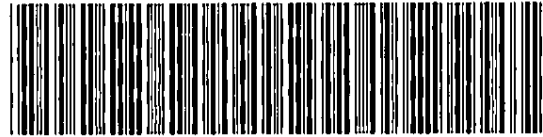

ARTICLE I – NAME

THE NAME OF THIS CORPORATION IS:
