ARTICLE I
NAME AND ADDRESS

The name of this corporation is FUTUREFIRST WEALTH MANAGEMENT HOLDINGS CO. The principal office and the mailing address of the corporation is 401 E. Jackson Avenue, Suite 3100, Tampa, Florida 33602.

ARTICLE II
DURATION

This corporation shall have perpetual existence.

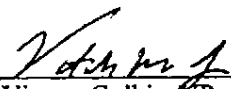
