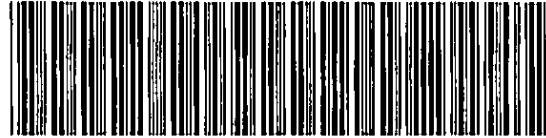

The undersigned incorporator to the Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be **ASK REALTY, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal office of this corporation shall be located at **2322 NW 26TH PLACE**, the City of **CAPE CORAL**, State of **FLORIDA**, and the post office address of said principal office of the corporation shall be **2322 NW 26TH PLACE, CAPE CORAL, FLORIDA 33993**

ARTICLE III. PURPOSE

3. **Contracts.** No contract or other transaction between the corporation and any other firm, association, or corporation shall be affected or invalidated by the fact that any one or more of the directors of the corporation is or are interested in or is a member, director, or officer or are members, directors, or officers of such firm or corporation and any director or directors individually or jointly may be a party or parties to or may be interested in any contract or transaction of the corporation or in which the corporation is interested; and no contract, act, or transaction of the




