ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the Corporation is Ticha Chancey Fender, P. A.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - NATURE OF BUSINESS

(Special Purpose)

The special purpose for which this corporation is being organized shall include the practice of Licensed Real Estate Sales and services as a Licensed Real Estate Sales Corporation and to carry on services incident thereto, the practice of general licensed Real Estate Sales and Services is the sole and exclusive professional service to be rendered by this corporation. The licensed Real Estate Agent services of this corporation shall be carried out only through officers, employees and agents each of who has been admitted to practice and are licensed in the State of Florida and duly authorized to practice as Licensed Real Estate Agents in the State of Florida. - **B.** To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporation indebtedness as required.
- C. To purchase the corporation assets of any other corporation and engage in the same or other charter of business.
- **D.** To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire and dispose of the shares of the capital stock or any bonds, securities, or other evidence of indebtedness, created by any other corporation of the State of Florida

or any other state or government and whole owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

E.
