I spoke with my husband, Edward Sichler, and he asked me to handle it on his behalf.


I spoke with Lea Rivers, on the Internet Help Desk, and he said that we needed to file a "Statement of Fact," advising the Department of Corporations that a corporation had been opened without our knowledge and that they should be aware that fraud has transpired. He said that there was nothing that he could do and no one that we could contact, other than to write this letter.

I spoke with a friend, Gail Stage, a Federal Public Defender, and she directed me to:

1. File a police report with Davie Police Department, Case #17-52708, Filed under Fraud, Officer Selizer
2. Place a "Fraud Alert" with our credit monitoring
3. Contact the 3 major credit reporting agencies
4. E-Filed on 8/29/2017, Articles of Dissolution, Confirmation #300303113823

Please be advised that this is a fraudulent corporation and all dealings with it should be directed to the Town of Davie for prosecution.
