

ARTICLES OF INCORPORATION

OF

BLACK CREEK DISTILLERIES, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name of the corporation is BLACK CREEK DISTILLERIES, INC.
