FOURTH: None of the corporation's shares have been issued.


FIFTH: No debt of the corporation remains unpaid.

SIXTH: The net assets of the corporation remaining after winding up, if any, have been distributed to the original incorporator and investor.


SEVENTH: The sole incorporator has authorized the dissolution and the original named directors have authorized the dissolution.

EIGHTH: The effective date of the dissolution of the corporation shall be the filing date with the Florida Secretary of State, Division of Corporations.


