2. I was/am the President of the Florida for profit corporation bearing the name Ameriloss Incorporated, which was administratively dissolved on September 23, 2016.

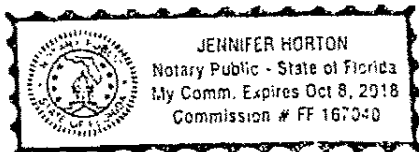
