The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Swet Management, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 999 Explorer Cove, Altamonte Springs, FL 32701. The mailing address of the Corporation shall be 370 North Street, Longwood, FL 32750.

ARTICLE III - CAPITAL STOCK
