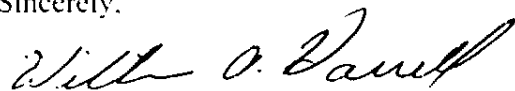

ARTICLE I. NAME

The name of this corporation is HARRELL & HERRELL LAWN SERVICES, INC.

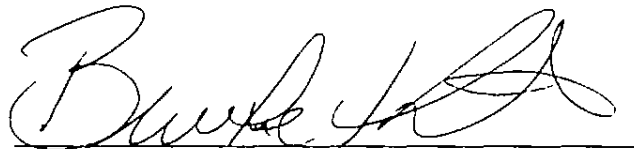
