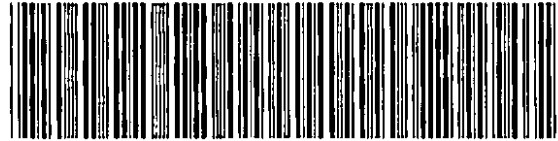

The undersigned, acting as Incorporator of a Professional Service Corporation pursuant to the Professional Service Corporation and Limited Liability Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME**

The name of the corporation shall be: TODD C. PASSMAN, P.A.

**ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS**
