ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ATLANTIC ACCESS SCAFFOLDING INC.

Pursuant to the Florida Business Corporation Act (the "Act"), ATLANTIC ACCESS SCAFFOLDING INC., a Florida corporation (the "Corporation"), does hereby amend its Articles of Incorporation as follows:

FIRST: The name of the Corporation is: ATLANTIC ACCESS SCAFFOLDING INC.

SECOND: The original Articles of Incorporation of the Corporation were filed with the Florida Department of State on September 29, 2017.

THIRD: The document number of the Corporation is: P17000078835.

FOURTH: The Corporation's Articles of Incorporation are hereby amended as follows:
