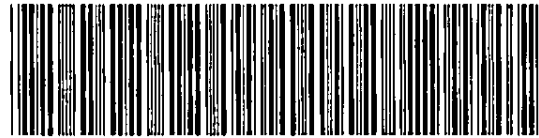

1. Introduction. Joseph Hocroft, being duly sworn, deposes and says:



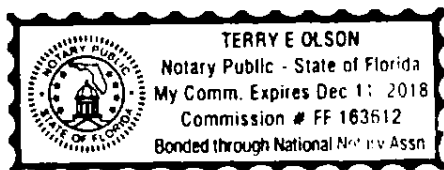
