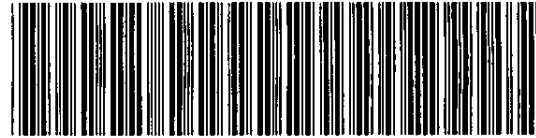




SECOND. The Articles of Incorporation are hereby amended to modify Article I, "Name," and restate the applicable article as follows:
