ARTICLES OF INCORPORATION

NEAMATCO INVESTMENT, INC.

WE, the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida and adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: NEAMATCO INVESTMENT, INC. with its principal office address at: 619 N. State Road 7, Margate, Florida 33063.

ARTICLE II

The corporation is organized for the following purposes:

- (a) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
