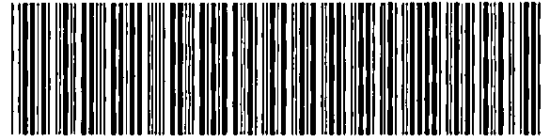

**ARTICLE I - NAME**

The name of this corporation is Envision Children's Healthcare Services of North Mississippi, Inc. (the "Corporation").

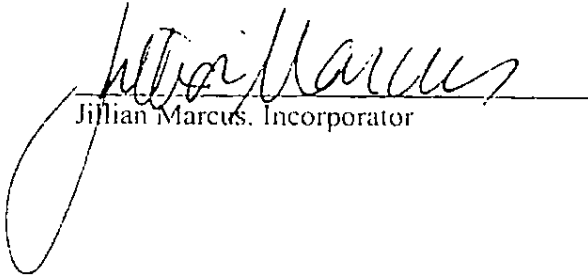
