#1 - The main principal address of the Corporation was changed from 5242A S Orange Ave, Orlando, FL 32809 to 3956 Town Center Blvd #120 Orlando, FL 32837

#2 - The Director Pedro Antonio Ramirez was removed altogether with his address

#3 - Was signed as me when I did not process nor authorized this amended filing.

I have contacted our company Registered Agent which is Attorney David M. Chico and he confirmed he as well did not process this filing nor authorized it, therefore we have no idea who would do such a thing and file fraudulently. The Attorney advised me to contact the Division of Corporations to fix everything back to how it was originally on the Sunbiz Document for our Entity.

I called the Division of Corporation this morning and spoke with a representative named Duwait. He advised me to fix all back by filing another Amended Annual Report and correcting all back to its original state. He also advised me to send this letter Statement of Fact through the mail to you. He mentioned to me that since all is processed as face value in the system that the filing fee of \$61.25 could not be waived even though the special circumstances of the case. I asked how we can avoid this ever happening again to any of my entity's corporations within the system since this is the 1st time this has ever happened to me. Duwait said that unfortunately there are No Security Features to protect fraudulent filings.

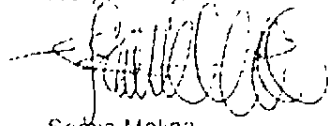
I am concerned and would love to secure it all with a pin or something.

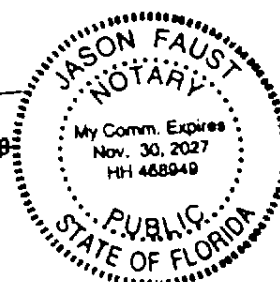

I have also attached Pedro Ramirez FL ID to this Letter as verification.

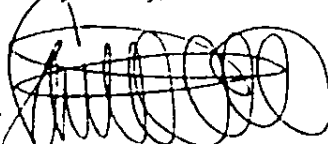

I am requesting for this my Real & True Statement of Fact to be posted up to Sunbiz as a public record.

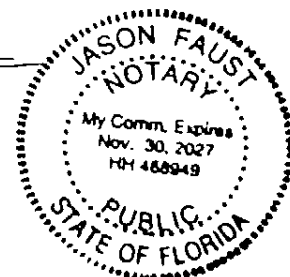

Good afternoon,

I received your statement of fact which is attached above but it needs to be notarized. Once notarized please email and I will get it posted to SUNBIZ as public record.

The Division of Corporations acts in an administrative filing capacity only. The Department of State does not have prosecutorial authority, that would need to be pursued by law enforcement with the appropriate jurisdiction. We would be able to assist in their investigation by providing records in our possession, but we do not have the authority to bring charges against an individual. As such, all documents submitted and filed by our office are accepted at face value. Section 817.155, F.S., states "a person may not, in any matter within the jurisdiction of the Department of State, knowingly and willfully falsify or conceal a material fact, make any false, fictitious, or fraudulent statement or representation, or make or use any false document, knowing the same to contain any false, fictitious, or fraudulent statement or entry. A person who violates this section is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084". **Any disputes or fraudulent filings must be resolved between the affected parties or in the courts**
