1. Introduction. Julius C. Garcia, being duly sworn, deposes and says:



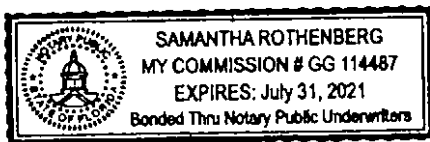
