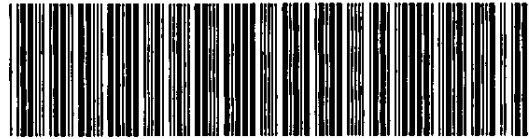

COASTAL AUTO COLLISION & CUSTOMS, INC.




