ARTICLES OF INCORPORATION

OF

The undersigned acting as Incorporators and Initial Directors of TranscenDENTAL Studio, P.A., under the Florida Statute, Chapter 621, adopts the following Articles of Incorporation:

ARTICLE I - NAME
