**PREEMPTIVE RIGHTS OF SHAREHOLDERS**

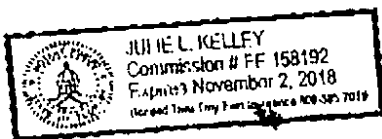


