
**ARTICLE XII BYLAWS**

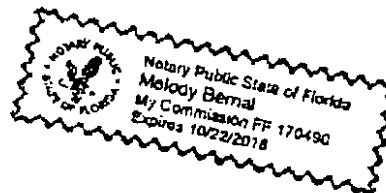


