

- 1. She is the President of BHR Investments, Inc., a New York corporation (the "Corporation").
- 2. The Corporation submitted an Application by Foreign Corporation for Withdrawal of Authority to Transact Business or Conduct Affairs in Florida Articles of Amendment (the "Application") to withdraw its ability to transact business in Florida on or about November 27, 2017, a copy of the filed Application is attached as EXHIBIT A.
