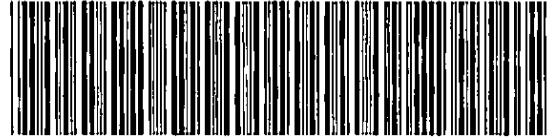

PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES, MICHAEL S. RUBIN OF 2436 PLUMADORE DRIVE GRAND ISLAND FLORIDA 32735 IS HEREBY NAMED AS REGISTERED AGENT OF THIS CORPORATION TO ACCEPT SERVICE OF PROCESS WITHIN THE STATE OF FLORIDA. THAT MICHAEL S.
