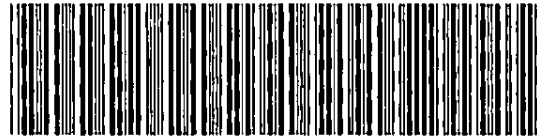

*Name.* The name of this Corporation is Equine Environmental Services, Inc.

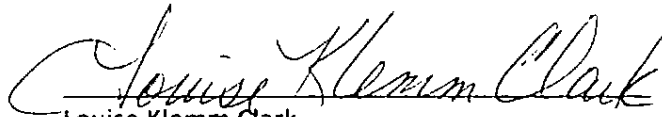

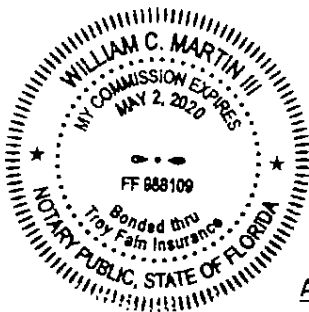

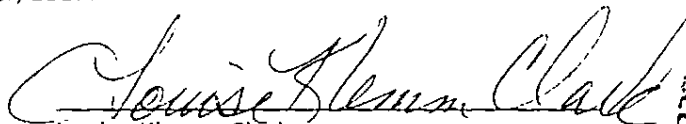
