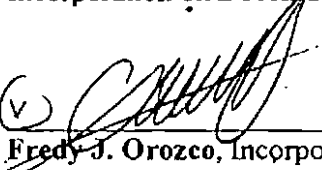
ARTICLE XIV: AMENDMENT

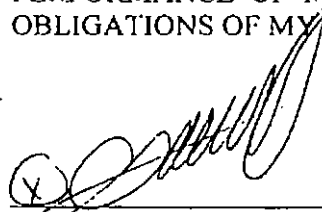
