**ARTICLE I: NAME**

The name of the corporation shall be: Always Parts.com Inc

The term of existence of this corporation is perpetual and shall be effective January 1, 2018.

**ARTICLE III: PURPOSE OF THIS CORPORATION**

This corporation is organized to engage in, or transact the business of appliance parts sales and all business activities related thereto, and all other lawful business and/or activities for which corporations may be incorporated under the laws of the United States of America, The Florida General Corporation Act, the State of Florida, and/or any other state, country, territory, or nation.

### **ARTICLE VIII: INITIAL BOARD OF DIRECTORS**



- (D) The corporation shall indemnify each director and officer of the corporation against all or any portion of any expenses reasonably incurred by him/her in connection with or arising out of any action, suit or proceeding in which he/she may be involved, by reason of he/she being or having been a director or officer of the corporation [whether or not he/she continues to be a director or officer at the time of incurring such expense(s)], to the full extent permitted by and subject only to the limitations and provisions of the laws of the State of Florida and the United States of America.


