In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following artifles of incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The principal place of business of the corporation is: 777 N. Ocean Dr., Unit S-520, Hollywood, FL 33019.




ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT
