The undersigned, acting as the incorporator of KR MAS Holdings, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

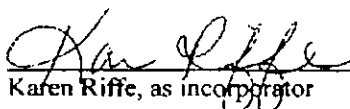

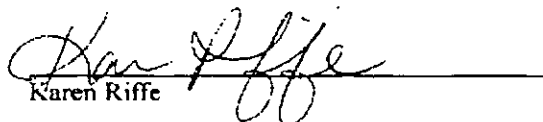
