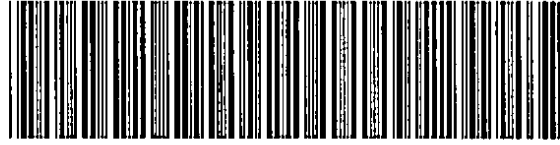


ARTICLE 10


