#### **ARTICLES OF INCORPORATION**

# HIGHLANDS LEGAL SOLUTIONS, P.A.

The undersigned, acting as director for the purpose of forming a corporation in accordance with the Laws of the State of Florida, adopts the following Articles of Incorporation.

## **ARTICLE I**

The name of the corporation shall be HIGHLANDS LEGAL SOLUTIONS, P.A., and its initial place of business shall be at 2009 Country Aire Loop, in the City of Bartow, in the County of Polk, and the State of Florida.

#### **ARTICLE II**

The principal street address of the corporation shall be 2009 Country Aire Loop, Bartow, FL 33830. The principle mailing address of the corporation shall be P.O. Box 1144, Bartow, FL 33831.

#### ARTICLE III

The corporation elects to be a professional association in accordance with Chapter 621, Florida Statutes (2017) (Chapter 621). The corporation furthermore elects to be a social purpose corporation in accordance with Chapter 607, Part II, Florida Statutes (2017) (Chapter 607).

The business purpose and public benefit for which the corporation is organized is to provide professional attorney services to low-income or underserved individuals and communities.

If a conflict exists between Chapter 621 and Chapter 607, Chapter 621 shall prevail. If a conflict exists between the Rules Regulating the Florida Bar (RRTFB) and Chapter 607, the RRTFB shall prevail.

#### **ARTICLE IV**

The total number of shares authorized to be issued by the corporation shall be two thousand hundred (2,000) with a par value of \$0.01.

#### **ARTICLE V**

- 3. The employees and work force of the social purpose corporation, its subsidiaries, and its suppliers;
- 4. The interests of customers and suppliers as beneficiaries of the public benefit or specific public benefits of the social purpose corporation;
- 5. Community and societal factors, including those of each community in which offices or facilities of the
- social purpose corporation, its subsidiaries, or its suppliers are located;
- 6. The local and global environment; and
- 7. The short-term and long-term interests of the social purpose corporation, including benefits that may accrue to the social purpose corporation from its long-term plans and the possibility that these interests may be best served by the continued independence of the social purpose corporation.
