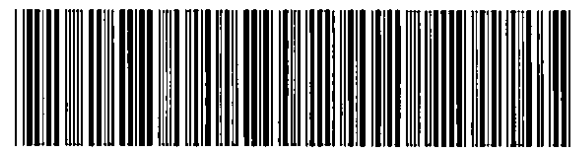

Article 4 of the Corporation's Articles of Incorporation is hereby amended to increase the authorized shares of stock of the Corporation and to provide for the issuance of Common Class A Voting Shares and Common Class B Non-Voting Shares. The number of authorized shares of stock of the Corporation shall be as follows:

Class	Par Value Per Share	Number of Shares Authorized
Common Class A Voting	None	5,000
Common Class B Non-Voting	None	95,000

The entire voting power shall be vested in the Common Class A Voting Shares and each Common Class A Voting Share shall be entitled to one vote. The Common Class B Non-Voting Shares shall not be entitled to any vote except as may be required by law.

The Corporation intends to issue 500 Common Class A Voting Shares and 9,500 Common Class B Non-Voting Shares.

The existing shareholders of the Corporation will exchange the shares of stock held by them in exchange for a proportionate amount of Common Class A Voting Shares and Common Class B Non-Voting Shares based on the percentage interest of stock held by such stockholder in the Corporation currently.


