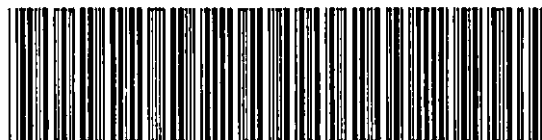


ARTICLE IX


