# STATEMENT OF FACT FRAUDULENT ENTITY – WELDON INDUSTRIES ASSOCIATION INC.

- I. My name is Mark C. Weldon.
- 2. I am the Director and President of Weldon Industries, Inc.
- 3. I created and incorporated Weldon Industries, Inc. in 2003.
- Weldon Industries, Inc.'s principal and mailing address are the same: 4914 Joanne
   Kearney Blvd., Tampa, FL 33619.
- 5. On January 9, 2018, Jason J. Bargewell fraudulently filed articles of incorporation for Weldon Industries Association Inc. These articles were assigned document number P18000002747. These articles are fraudulent.
- 6. Weldon Industries Association Inc.'s fraudulent articles of incorporation identify the corporation's purpose as "any and all lawful business." <u>Unfortunately, it appears the corporation's only purpose is fraudulent and criminal.</u>
- 7. The fraudulent articles of incorporation identify Weldon Industries Association Inc.'s principal place of business as 4914 Joanne Kearney Blvd., Tampa, FL 33619 (the same as Weldon Industries, Inc.'s principal place of business).
- 8. Weldon Industries Association Inc. is a fraudulent entity and does not exist—
  if at all—at Weldon Industries, Inc.'s principal place of business.
- 9. Weldon Industries Association Inc.'s fraudulent articles of incorporation identify its mailing address as 1157 Highland Ct. N., St. Petersburg, FL 33701.
- 10. According to the Pinellas County Property Appraiser, 1157 Highland Ct. N., St. Petersburg, FL 33701 is a residential property.

- According to the Pinellas County Clerk of Court, Jason J. Bargewell identifies
   Highland Ct. N. Apt. 1, St. Petersburg, FL 33701 as his residence.
- 12. Weldon Industries Association Inc.'s fraudulent articles identify Jason J.

  Bargewell as the fraudulent entity's Incorporator, President, and Registered Agent.
- 13. According to the Pinellas County Clerk of Court, Jason J. Bargewell has 21 closed, and 4 open, criminal cases against him.
- 14. Notably, Case No. 18-00619-CF, filed on January 17, 2018, involves charges for the fraudulent use of personal information to open false business accounts to deposit two checks into. According to the Complaint/Arrest Affidavit, Jason J. Bargewell was arrested on these charges on January 16, 2018. It states that he "produced fraudulent information on his false business to deposit checks."
- 15. It appears that Jason J. Bargewell is using the fraudulent entity—
  Weldon Industries Association Inc.—to perpetrate the same crime against my company,
  Weldon Industries, Inc.
- Jason J. Bargewell and Weldon Industries Association Inc. are not affiliated with Weldon Industries, Inc.
- Jason J. Bargewell and Weldon Industries Association Inc. have no authority whatsoever on behalf of Weldon Industries, Inc.
- 18. Jason J. Bargewell and Weldon Industries Association Inc. are not authorized to use the Weldon or Weldon Industries names for any purpose whatsoever.
