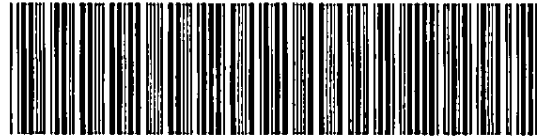

ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation shall be: VM DISTRIBUTORS PARTNERS, INC.

ARTICLE II

The principal place of business and mailing address of the corporation is:

The Corporation is created for the purpose of engaging in any and all businesses allowed and permitted under the statutes of the State of Florida, and to do any and all of the business hereinafter mentioned as fully, and to the same extent as natural persons might engage, or could perform; as follows:

Exercise any and all powers which are now, or hereafter authorized by law, and generally do and perform any and all things necessary or incidental to the performing, or carrying out of the powers herein specifically delegated or implied.

ARTICLE IV

The aggregate number of shares that the Corporation shall have the authority to issue is: SEVEN THOUSAND FIVE HUNDRED (7,500) SHARES of Capital Stock, with a par value of One Dollar (\$1.00) per share.

The Initial Issue of shares of the Capital Stock of the Corporation will be (100) shares, for cash at a par value of One Dollar (\$1.00) per share.

The Holders of the outstanding capital stock, shall be entitled to receive, when and as declared by the Shareholders; dividends payable either in cash, property, or in shares of the Capital Stock of the Corporation.

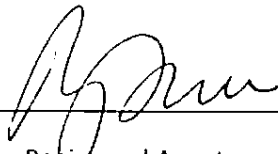
ARTICLE VIII

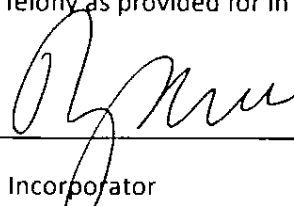

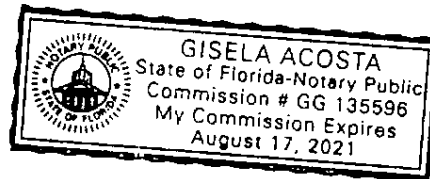
