The undersigned, acting as incorporator of PRINCE WOODS PUBLISHING, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name and street address of the incorporator is Jorge Hernandez-Torano, 701 Brickell Avenue, Suite 3300, Miami, FL 33131.


ARTICLE IX. BYLAWS
