



The undersigned subscriber(s) to these Articles of Incorporation, each a natural that I start person competent to contract, hereby associate themselves together to form a HASSEE, FLORIDA corporation under the Laws of the State of Florida.

#### **ARTICLE I. - NAME**

The name of this corporation is: J DOUBLE C HOME INSPECTIONS INC

#### ARTICLE IL - NATURE OF BUSINESS

#### TO ENGAGE IN ALL ASPECTS OF THE HOME INSPECTION PROFESSION.

The general nature of the business to be transacted by this corporation shall be:

- a) To engage in the buying and selling of any and all types of commercially traded products, within the United States or the purchasing and sales can be a world wide activity and to engage in any and all functions, services and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
