The undersigned, acting as incorporator of a Florida corporation under Florida Statutes, Chapter 607, Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I
NAME AND ADDRESS

The name of the Florida corporation shall be E-Guide Corporation, referred to herein as the "Corporation." The address of the principal office and the mailing address of Corporation shall be 4420 Beacon Circle, West Palm Beach, Florida 33407.

ARTICLE II
EFFECTIVE DATE

The effective date of these Articles of Incorporation shall be the date upon which these Articles are duly filed in the State of Florida.

ARTICLE II
PURPOSE

The purpose for which the Corporation is organized and the general nature of the activities shall be as follows:
