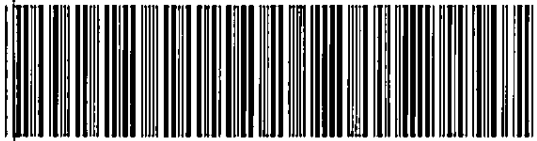

Article 1: Name

Article 3: Purpose

The Corporation is a social purpose corporation under Part II, Section 607.501 through 607.513 of Chapter 607, Florida Statutes.
