

CERTIFICATE OF INCORPORATION

We, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Several Acts of Legislature of the State of Florida, do hereby subscribe to this coxtificate of incorporation.

PIRST: The name of the corporation shall be:

SECOND: The business of this corporation shall be to engage Mix and all lawful business or businesses.
