

ARTICLE 1-NAME

RECORDED
TALLAHASSEE, FLORIDA

The name of this Corporation is Clintrex Research Corporation.

ARTICLE II-NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III-CAPITAL STOCK

The authorized capital of the Corporation shall be 100,000 shares of the common stock at a par value of \$0.01 per share.

ARTICLE IV-TERM OF EXISTENCE

This Corporation is to exist perpetually.

ARTICLE V-PREEMPTIVE RIGHTS



The existence of this Corporation shall commence on the date of filing these Articles of Incorporation with the Secretary of State.


