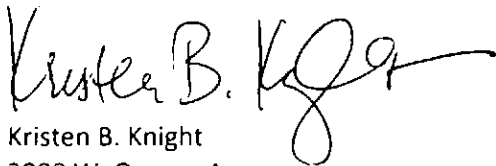
Mr. Caldwell:

Knight as a partner without my knowledge or consent. Although the perpetrators used their own address (920 Coral Ridge Drive, Unit 304, Coral Springs, FL 33071), they used my Name and an old address as registered agent.

I am currently the victim of a number of attempts of identity theft from this same address in Coral Springs and would appreciate it if you would put the notice out for public record that I am not nor have ever been a part of K Knight Enterprises.

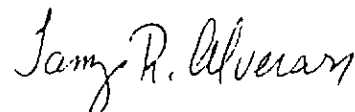
