Wa, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the several Acts of Legislature of the State of Florida, do hereby subscribe to this cartificate of incorporation.

FIRST: The name of the corporation shall be:

SECOND: The business of this corporation whell be to engage in any and all lawful business or businesses.

THIRD: The Corporation shall have one class of stock, namely common, voting and participating. Each share of stock shall be \$1.00 par value and the maximum number of shares to be issued and outstanding at any one time is 100.

All of such stock shall be issued as fully paid for and exempted from assessment.
