TO THE

SCRIVEN FRAZIER, P.A., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on February 14, 2018 and amended on March 27, 2018.
2. Pursuant to Section 607.1006, Florida Statutes, this amendment to the Articles of Incorporation was approved by unanimous written consent of the shareholders of the common stock of the Corporation as of April 4, 2018. The number of votes cast by holders of the common stock was sufficient for approval.
3.
