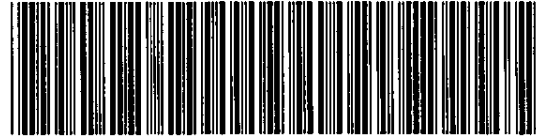

Article I – Name

The name of the corporation is: Freedom Cruise Line International, Inc.

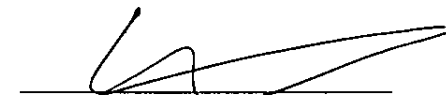

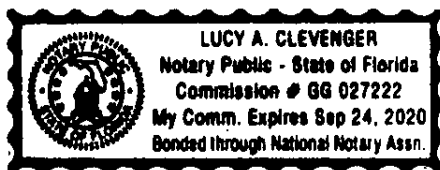
