ARTICLES OF INCORPORATION OF Victoria Morin M.D. Medical Aesthetics, P.A.

ARTICLE I NAME, PRINCIPAL PLACE OF BUSINESS, AND DURATION

The name of the Corporation is Victoria Morin M.D. Medical Aesthetics, P.A. The street address of the initial principal office of the Corporation is 1912 Heritage Estate Drive, Lakeland, Florida, 33803. The duration of the Corporation is perpetual.

ARTICLE II REGISTERED OFFICE AND AGENT
