
ARTICLE XI. AMENDMENT

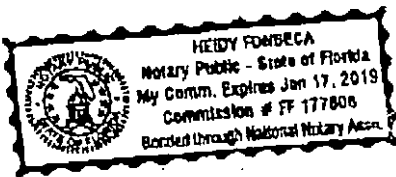
