ARTICLES OF INCORPORATION
OF
CONDUSIV TECHNOLOGIES CORPORATION

The undersigned, acting as incorporator of ConduSiv Technologies Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is ConduSiv Technologies Corporation.

ARTICLE II. ADDRESS

The mailing address of the corporation is 3001 North Rocky Point Drive East, Suite 200, Tampa, Florida 33607.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing these articles of incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 100,000 shares of common stock having a par value of \$0.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 11380 Prosperity Farms Road #221E, Palm Beach Gardens, Florida 334106, and the name of the corporation's initial registered agent at that address is Corporate Creations Network Inc.

ARTICLE VII. INCORPORATOR

The corporation reserves the right to amend, alter, change or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.


