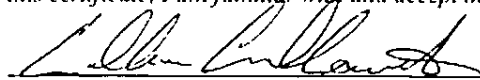

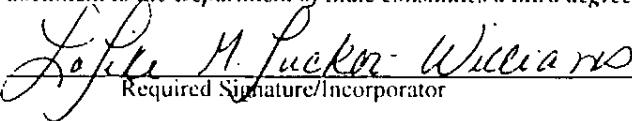

### Article III Purpose

- a) To engage in lawful activity such as: the rights, privileges and powers of corporations.
- b) Tiki's Hair Emporium Corporation may be exercise contracts and succession. In addition to have the power to purchase, hold and convey real and personal estate.
- c) Tiki's Hair Emporium Corporation is organized to have power to appoint officers and agents, as the affairs of the corporation require, and to allow them suitable compensation.
- d) Tiki's Hair Emporium Corporation to have the power to make By-Laws consistent with the constitution or law of the United States, or of the State of Florida; for the management, regulation, and government of its stock, transaction of its business and calling and holding of meetings of its stockholders.
- e) Have the power to dissolve it or be dissolved.
- f) Also, Tiki's hair Emporium Corporation shall have the power to adopt and use a common seal or stamp at pleasure. The use of the seal or stamp by the corporation on any corporate documents is not necessary. The corporation may use a seal or stamp, if it desires, but such use or no use shall not in any way affect the legality of the document.
- g) To borrow money and contract debts when necessary for transaction of its business, or for the exercise of its corporate rights, privileges, or franchise or for any other lawful purpose of its incorporation.
- h) To issue bonds , promissory notes, bills of exchange, and other obligations and evidence s of indebtedness, payable at a specified event or events whether secured by mortgage, pledge, or otherwise, or unsecured, for money borrowed, or in payment for property purchased, or acquired, or for any other lawful object.
- i) To guarantee, purchase, sell, assign, transfer, mortgage pledge or otherwise dispose of shares of the capital stock of, or any bonds, securities or evidences of the indebtedness created by any other corporation or corporations of the State of Florida or any other state or government. In addition to all these rights and privileges the right to vote, if any.
- j) Shall have the power to make donations for the public welfare or for the charitable, scientific or educational purposes.
- k) To enter into partnerships, general or limited, or joint venture in connection with any lawful activities.
